We received notification Sunwing filed for conciliation today.


After several months of meaningful bargaining, your Bargaining Committee and Sunwing have reached an impasse.

We are satisfied with the language captured to date, yet some of what can be the most tenuous hurdles remain outstanding, items both directly and indirectly associated with monetary compensation.

At this stage of the process we view this as a positive milestone. The conciliation process under the guidance of an independent third party professional provides a format for the parties to reach agreement through definitive and aggressive timelines. Please refer to chart below.
